Revised Selection criteria for selection of Mission Shakti SHGs(MSG):

- MSG should be from the same ward (in the absence of an eligible group, the MSG from the nearby ward may be considered with the committee's approval).
- 2. MSG must be at least one(1) year old as on the date of application.
- 3. MSG must be strictly following the Panchasutra.
- 4. The minimum qualification of any member of the MSG should be matriculation.
- 5. MSG must have a Permanent Account Number (PAN).
- 6. MSG must have been previously engaged in income-generating activities.
- MSG must not have records of financial irregularities (such as loans declared NPA and write-offs etc.).
- 8. MSG must not have a record of involvement in any anti-social or Criminal activities.
