- 4) Bids received on "online" shall be opened at **12.00 Noon** on **24.11.2020** in the office of the undersigned in the presence of the bidders or their authorized agents who wish to attend. If the office happens to be closed on the date of opening of the bids as specified, the bids will be opened on the next working days at the same time and venue.
- 5) The Bid document shall contain scan copy of (i) Registration Certificate, (ii) PAN, (iii) Cess Certificate from Dist.
