- 2) The bidders must possess compatible Digital Signature Certificate of class II or Class III.
- 3) Bids must be submitted on "**online**" on or before **18.10.2021 by 17.30 Hrs.**
- 4) Bids received on "online" shall be opened at **11.00 Hrs on 21.10.2021** in the office of the undersigned in the presence of the bidders or their authorized agents who wish to attend. If the office happens to be closed on the date of opening of the bids as specified, the bids will be opened on the next working days at the same time and venue.
- 5) The bidders are to submit the bid in online mode with the requisite **cost of tender paper (non Refundable). The respective E.M.D are not required as per the notification No.7963/HUD-BUD-01/2021 Dtd.12.04.2021 during submission of bids. However the same is to be produced (Off line Mode) by the successful bidder after award of the contract.**
- 6) All the relevant document as per DTCN should be uploaded in the portal at correct places.
- 7) The bidder **claiming any sorts of price preference or E.M.D Exemption** etc. against the **Engineer Contractor License , Scheduled caste/ Schedule tribe / Handicapped** contractor license should invariably produce the **original contractor license in person** for verification & entry as the case may be after the scheduled opening of the respective bids, prior to signing the agreement.
- 8) The Bid document shall contain scan copy of (i) Registration Certificate, (ii) PAN, (iii) Cess Certificate from Dist. Labour office (v) Litigation Certificate (Appendix-A) (vi) Affidavit (Appendix-B), (vii) Experience certificate, as regards similar nature of work Rs.1,000,000.00 in a year (Appendix-C), (viii) List of T & P (Appendix-D), (ix) No Relation Certificate (Appendix-E) (Appendix and check list are available in DTCN) , Other document required as per DTCN and special condition if any in cover-I
- 9) Price bid shall be submitted in cover -I of online bidding.
- 10) Any bidders desirous to avail any facility as per certain circular/orders of Govt. have to apply for the same in affidavit along with copy of the circular/order.
- 11) The sealed Bid document shall contain scan copy of (a) Registration certificate (b) PAN, (c) **Experience certificate as regards similar nature of work Rs.10,00,000.00 in a year** (e) Cess certificate from District Labour office and other document required as per DTCN and special condition if any.
- 12) The authority reserves the right to cancel any or all bids without assigning any reason thereof.
