- 1) Bid documents will be available in website www.tendersorissa.gov.in from **06.03.2018 11.00 Hrs** to **21.03.2018 by 17.00 Hrs** for online bidding. The bidders must possess compatible Digital Signature Certificate of class II or Class III.
- 2) Bids must be submitted on "**online**" on or before **21.03.2018 by 17.00 Hrs.**

- 3) Bids received on "online" shall be opened at. **11.00 Hrs** on **22.03.2018** in the office of the undersigned in the presence of the bidders or their authorized agents who wish to attend. If the office happens to be closed on the date of opening of the bids as specified, the bids will be opened on the next working days at the same time and venue.
- 4) Bids must be accompanied with scan copy of financial instrument towards bid security (EMD) specified for the work in column No.4 of the aforesaid table, in the form of demand draft/ Banker Cheque on any Nationalized Bank / Fixed deposit receipt of schedule Bank/ Kishan Vikash Patra/ Post Office Savings Bank Account/ National Savings Certificate/ Postal Office Time Deposit Account duly pledged in favour of the Executive Officer, Bargarh Municipality Bargarh payable at Bargarh, Orissa. Scan copy of the bid security shall be submitted in cover-I of the online bidding. Bidders desirous to hire machineries (or) equipments from outside the state are required to furnish 2% of the amount put to tender as bid security. Engineer contractors who want to avail EMD exemption have to give one affidavit with tender declaring therein to the affidavit that they have not yet availed 3 nos. of EMD exemption during this financial year and to show the original Registration certificate to the tender opening authority for conformation. However in case, the above Engineer contractor desire to engage machineries/equipments as asked for in the bid documents, owned or hired but deployed outside the state they are required to furnish 1% of the amount put to tender as bid security rounded off to the nearest one hundred Rupees.
- 5) Bids must be accompanied with scan copy of demand draft towards cost of tender document specified in the work in column No.5 of the aforesaid table. The same shall be in the form of demand draft/ Banker Cheque on any Nationalized Bank, in favour of the Executive Officer, Bargarh Municipality, Bargarh, payable at Bargarh, Orissa. Scan copy of the demand draft shall be submitted in cover - I of the online.
- 6) The Bid document shall contain scan copy of (i) Registration Certificate, (ii) PAN, (iii) Cess Certificate from Dist. Labour office (v) Litigation Certificate (Appendix-A) (vi) Affidavit (Appendix-B), (vii) Experience certificate, as regards similar nature of work Rs.1,000,000.00 in a year (Appendix-C), (viii) List of T & P (Appendix-D), (ix) No Relation Certificate (Appendix-E) (Appendix and check list are available in DTCN) , Other document required as per DTCN and special condition if any in cover-I
- 7) Price bid shall be submitted in cover -I of online bidding.
- 8) Financial instrument such as cost of bidding document and bid security in original shall have to be deposited before the tender opening authority in between the date and time of closing and opening of the tender on working days, failing which the bids shall be summarily rejected.
- 9) Any bidders desirous to avail any facility as per certain circular/ orders of Govt. have to apply for the same in affidavit along with copy of the circular/order.
- 10) The sealed Bid document shall contain scan copy of (a) Registration certificate (b) PAN, (c) **Experience certificate as regards similar nature of work Rs.1,000,000.00 in a year** (e) Cess certificate from District Labour office and other document required as per DTCN and special condition if any.
- 11) The authority reserves the right to cancel any or all bids without assigning any reason thereof.
